### CE 517/2014 - Art. 6 - Keeping records - point 3

For the purposes of Article 11, paragraph 4, undertakings providing fluorinated greenhouse establish registers containing relevant information relating to purchasers of fluorinated greenhouse gases, including the following details:

- a) the certificate numbers of buyers;
  - b) the respective amounts of fluorinated greenhouse purchased.
- Undertakings providing fluorinated greenhouse retain such records for at least five years.

Undertakings providing fluorinated greenhouse, on request, shall make the records available to the competent authority of the Member State concerned or the Commission. To the extent that the registers contain environmental information, apply, as appropriate, Directive 2003/4/EC and Regulation (EC) n.1367/2006.
